Criminal: Appeal; timeliness of petition for return of property. (Daniels111617L)

Criminal: Suppression motion; vehicle stop; validity of consent for blood draw; totality of the circumstances; voluntariness; requirement of *Miranda* warnings at the time of the blood draw. (Portanova111617bt)
