## Executive Director's Report to the General Membership

## 9 January 2006

I am pleased to report that 2005 was a successful year both personally and professionally for me as Executive Director of the Lycoming Law Association. The goals that I set for myself, and that we set for the Association, were met, and I believe, well exceeded.

One of the most important events affecting the Lycoming Law Association in 2005 (and leading into 2006) was the ascendancy of local attorney William Carlucci to the presidency of the Pennsylvania Bar Association. Lunch & Learns are scheduled through May of 2006, and so far, each program has been presented by one of you: that is, by a member of the Association, gratis. And don't worry: soon I will be contacting all of you again to schedule for September, 2006, through May, 2007! I am delighted to say that it is now possible to earn all of your CLE credits here in Lycoming County. It is our intention to give you only more opportunities to do so. We also presented our first Bridge the Gap Seminar here in Lycoming County in 2005, and will continue to do so, enabling new bar admittees to obtain these very important ethics credits in their home county.

I am also very pleased to have played some part in the rejuvenation of the Young Lawyers Division. We are lucky to have a group of young lawyers who feel a commitment to their profession and to their community, and who are willing to take the time and put the effort forth to revitalize a committee that for several years has been inactive. As you will see from its Report, the YLD has spent a great deal of time organizing and planning for the future. We welcome them, and applaud them.
