Minutes of the Annual Meeting of the Lycoming Law Association January 10, 2005

DECLARE QUORUM & OPEN MEETING

The Annual Meeting of the Lycoming Law Association was held on January 10, 2005, in the Jurors Lounge of the Lycoming County Courthouse. President John M. Humphrey declared there to be a quorum present and convened the meeting at 4:00 P.M.

MINUTES OF JANUARY 2004 MEETING

A motion was made by Mr. Weber and seconded by Mr. Askey that the minutes of the Annual Meeting held on January 12, 2004, be unanimously adopted. The motion was duly passed.

TREASURER'S REPORT

Mr. Knecht also reported that the Accountant's Report was received this date.

PRESIDENT'S REPORT

Mr. Humphrey reported that Jessica A. Engel was hired as Executive Director of the Lycoming Law Association and began her duties on April 19, 2004. He also reported that the Executive Committee decided to terminate the employment of the LLA secretary because she misappropriated the sum of \$5,856.22 from the LLA. Full restitution was made by the former secretary as of June 7, 2004. On a more positive note, Mr. Humphrey also reminded the members that Annabel Miller will be honored at the Annual Banquet this evening and he reported the accomplishments of the LLA during the past year which included the establishment of the Community Activities Fund and Community Activities and Outreach Committee and the presentation of the Louis J. Goffman Award to the LLA by the Pennsylvania Bar Association in recognition of the LLA's exemplary pro bono program and the history of the pro bono service of its members. Finally, Mr. Humphrey thanked Mr. Weber for his years of service to the LLA, his foresight in advocating the hiring of an Executive Director and his efforts in maintaining and improving the LLA website. Mr. Humphrey submitted a written report for the membership to read.
