## **ANNUAL REPORT OF THE FOUNDATION 2010**

## January 10, 2011

The Foundation provides the following report for 2010 which describes activities and accomplishments during the year.

The Annual Meeting was held on January 11, 2010. The narrative and financial reports presented on behalf of the Foundation were adopted unanimously. E. Eugene Yaw was nominated and unanimously elected to serve a four year term.

The Foundation also held meetings on the following dates: January 29, 2010, May 21, 2010, September 10, 2010, and December 10, 2010.

The Lycoming Law Association assigned the Muir Documentary project to the Foundation, without consideration. As a result, \$4,200 in contributions has been received to offset the costs of production.

In October of 2010, the LLA Young Lawyers Division again held its Lawctoberfest event, with its total proceeds being donated to the Foundation. That amount was approximately \$1,700.00. The Foundation is grateful for the YLD's continued commitment and hard work.

2009's Arbitration Fees resulted in a \$13,775.00 contribution to the Foundation, and therefore the 2010 contribution to North Penn Legal Services as a result of Arbitration Fees was \$11,020.00, or 80% as has been customary. 2010's Arbitration Fees has resulted in a \$9,950.00 contribution to the Foundation, and therefore the 2010 contribution to North Penn Legal Services as a result of Arbitration Fees was \$7,960.00, or 80% as has been customary. The Foundation also received a \$5,000 contribution from the LLA, as its yearly line-item contribution.

The Foundation, through its Community Outreach & Activities Fund, made grants to the following organizations:

North Penn Legal Services – FDCPA Training Grant

\$2,000.00 \$1,245.00

In addition, a disbursement was made from the Pro Bono Costs Litigation Reimbursement Fund in the amount of \$54.00.
