PRESIDENT'S REPORT 2020

2020 began like any other year for the LLA, but quickly morphed into a year unlike any other. The Annual Meeting was conducted at the LLA Office followed by a well-attended Annual Banquet held at Morrone's Restaurant. Annual award recipients were honored for their community service and pro bono work. While the evening was celebratory, the recent and sudden loss of Kristine Waltz weighed heavily on everyone's mind. The LLA, posthumously, awarded the Thomas Wood Award to Kristine. Her husband, Steve Sorage, was in attendance to receive the award.

In February, I attended the Conference of County Bar Leaders along with President-Elect Donald Martino and Michele Frey. LLA Members Rita Alexyn and Taylor Bucler were also in attendance. The conference focused on bar association governance and leadership. The LLA was honored with an award for its successful 2019 Wills for Heroes event, Project Linus blanket drive, Angel Tree collection, as well as Law Day and Mock Trial Competitions.

Early in March, I joined the Law Day Committee to plan for the 2020 Law Day Competition. Unfortunately, shortly after the details for the competition were announced, the pandemic had started to take hold in the United States and the schools in Pennsylvania were closed. While students were learning remotely, the competition was postponed. When it became clear that there would be no possibility of judging entries or celebrating winners, the 2020 Law Day events were cancelled.

Also, important to note is that the annual Angel Tree toy/book collection was a successful endeavor, despite the pandemic. This was a success due to the efforts of the donations received but also because of the tireless work of Corey Mowery and Michele Frey.

I am pleased that the LLA was able to have couple of safe, outdoor events. In July and August, the LLA hosted a wellness event, Yoga in the Park, for members and their guests. In October the LLA invited its members to pick

Kristine's family and friends outside of the profession were able to view it at their convenience. At the memorial service, I announced the LLA's decision to name future Wills for Heroes after Kristine Waltz.

Sadly, in 2020 the four attorneys passed away: Joe Rider, Don Larrabee, Dick Callahan, and Henry Perciballi. They will be greatly missed.
