



Tips for Submitting Information to Be Displayed in the Lycoming Law Association Attorney Directory

The following areas may be submitted for inclusion in the directory:

Practice Areas: A list of practice areas is appended to this document. The specific terms on the list are searchable with the Lycolaw Website search form. You may include additional practice areas that will display in your listing but will not be searchable on the site.

Organization

Title: If any. Includes "Judge", "Senator", "Magistrate Judge" and similar designations. Do not use terms like "attorney", "associate", "partner" or the like.

Birth date and place of birth: This is maintained in the LLA records, but is not displayed publicly

High School and graduation date

College: Format as - College name (degree) date

Law School: Format as - Law School name (JD) date

Pa Admission date: Year only

Other State Admissions: Format - State(year)

Federal Court Admissions: Examples of format - U.S.D.C. (M.D. Pa. 1986, E.D. Pa. 1993); U.S.C.A. (3rd Cir.1988); U.S.S.C. (1993)

Associations: Example format - P.B.A. (1983). Do not include the LLA membership.

Association Officer: Did you serve as an officer of the above associations (years)

Community involvement: Summarize community service with service organizations, religious organizations, boards of non-profits, etc.

LLA Committees: On which you serve or wish to serve.

Elected Office: List public office to which you were elected and the years of service.
