## ADMINISTRATIVE ORDER

AND NOW, this 2<sup>nd</sup> day of July 2020, pursuant to Order of the Supreme Court of Pennsylvania dated May 27, 2020, and in light of ongoing public health concerns relating to the COVID-19 pandemic, the President Judge of the 29<sup>th</sup> Judicial District is hereby exercising the powers granted by the Supreme Court and ordering that the 29<sup>th</sup> Judicial District emergency declaration is extended through August 7, 2020; and the following provisions apply through August 7, 2020 (unless a different date is indicated below) subject to state and federal constitutional requirements and any subsequent order by the Supreme Court:

- In-person court proceedings and in-person access to proceedings will be limited in order to safeguard the health and safety of court personnel, court users, and members of the public.
- 2. The following statewide rules are suspended:
  - Rules that restrict, directly or indirectly, the use of advanced communication technologies<sup>1</sup>; and
  - b. Rules pertaining to the rule-based right of criminal defendants to a prompt trial.
- 3. Jury selection and trials are suspended until the August/September trial term.
- To the extent possible, the Courts will decide matters on the papers and conduct proceedings utilizing advanced communication technology in order to limit in-person contact.
- Inmates will not be transported from the Lycoming County Prison or Prerelease Center for court proceedings. Incarcerated defendants will participate by advanced communication technology.

- 6. It is strongly encouraged that documents be filed via U.S. mail with the office of the Lycoming County Register and Recorder. The document and filing fee (check or money order only) must be in a closed envelope addressed to the appropriate filing office and a self-addressed, prepaid envelope must be enclosed for the return of a receipt for payment of filing fees and time-stamped copy of the document. If proper payment is not included, the document will be returned to the sender unfiled.
- 7. It is strongly encouraged that documents be filed with the Magisterial District Courts via U.S. mail to the applicable District Court office and payments for fines/costs/restitution be made via U.S. mail or online at https://ujsportal.pacourts.us/PayOnline.aspx.
- 8. Effective May 18, 2020, the Magisterial District Courts resumed the processing of evictions for which a judgment for possession was entered by the court prior to March 27, 2020.
- 9. Until further notice, **safety measures** including but not limited to the following will be implemented with all in-person proceedings:
  - a. Start times will be staggered and the time between proceedings will be increased in order to minimize person-to-person contact;
  - b. Generally, only necessary participants will be allowed entry to courtrooms and hearing rooms in order to minimize person-to-person contact;
  - c. Participants including but not limited to litigants, defendants, attorneys, and witnesses will practice social distancing in all areas of the Courts including but not limited to courtrooms and waiting areas unless the presiding judge authorizes otherwise;
  - d. A presiding judge and/or hearing officer may require participants including but not limited to litigants, defendants, attorneys, and witnesses to wear a facemask in courtrooms and/or hearing rooms.
  - e. Participants will **utilize the hand sanitizers** located in common areas and in courtrooms and hearing rooms;
  - f. High-touched surfaces will be cleaned and disinfected as practicable throughout the day; and
  - g. All surfaces will be thoroughly cleaned and disinfected after hours.
- 10. All **employees and court visitors** including but not limited to contractors and vendors will **practice social distancing** until further notice.
- Court employees will not attend off-site conferences or trainings until further notice.
- 12. Court events and meetings will be rescheduled or held via advanced communication technology until further notice.

- 13. Individuals on supervision will not report to the **Adult Probation Office** until further notice. Adult Probation will supervise individuals in the field or via advanced communication technology. Those individuals under supervision who have questions should contact their assigned probation officer.
- 14. Juveniles on supervision will report to the **Juvenile Probation Office** only as directed to do so until further notice. Those juveniles under supervision who have questions should contact their assigned probation officer.
- 15. The **Domestic Relations Office** will take measures to limit the number of individuals reporting to its office until further notice. Those with questions should contact the Domestic Relations Office for additional information.
- 16. These guidelines are fluid and continually subject to change as additional information becomes available. Questions or concerns should be directed to the Office of the District Court Administrator at 570-327-2330 or to the applicable Magisterial District Court.
