SUPPLEMENTAL NON-JURY ADJUDICATION AND VERDICT

The background of this Order is that this Court entered a non-jury trial adjudication and partial verdict, which was filed of record June 24, 2003. In accordance with the specific provisions of conclusions of law 18, 19, 20, and 21 thereof Plaintiffs' counsel was directed to prepare and file appropriate documentation of the monetary amounts due under the Court's determination that counsel fees, punitive damages and interest were to be awarded to Plaintiffs. That document was filed by plaintiffs' counsel on July 2, 2003. Under the Conclusions of Law and directions of the prior Order defense counsel was given a period of ten days after filing in which to make objection as to the manner of calculation of those amounts. No such objections have been filed. Accordingly, the following will be entered.

Order and Verdict

The Court hereby directs as an additional supplemental verdict and adjudication in this matter that Defendant Nationwide Mutual Fire Insurance Company shall pay to Plaintiffs Bryan D. Maneval and Nicole L. Maneval attorney fees and costs in the amount of \$36,714.50, punitive damages in

the amount of \$29,601 and interest in the amount of \$6,881.34 for a total due under this supplemental Order and Verdict of \$73,196.84.

It is further ORDERED and DIRECTED that upon payment of repaired/replaced contents and structure amounts as provided in the prior adjudication that punitive damages in the amount of \$3,186.36 shall be paid by Defendant to Plaintiffs.

It is further ORDERED and DIRECTED that pursuant to 42 Pa. C.S. §8371 that interest shall accrue on the amount due and payable of \$73,196.84 from the date of July 15, 2003 until the date of payment at the rate of \$7.34 per day.

This Verdict is in addition to and supplements the prior Adjudication and Verdict Order entered by this Court on June 24, 2003.
