Lovecchio Criminal: Post Conviction Relief Act petition; waiver of defects and defenses by plea of guilt; arguable merit of claim where the factual averments, if accurate, could establish cause for relief; requirement of factual hearing. (williams040920L) (Posted: April 9, 2020)
- ▶ Commonwealth vs. Steadley (04/09/2020)—Judge Marc F. Lovecchio Criminal: Post Conviction Relief Act petition; waiver of defects and defenses by plea of guilty; knowing, intelligent and voluntary guilty plea; prejudice. (Steadley040920L) (Posted: April 9, 2020)
- ▶ Commonwealth vs. Bean (04/09/2020)—Judge Marc F. Lovecchio Criminal: Post Conviction Relief Act petition; ineffective counsel; failure to request jury charge on lack of a prompt complaint in a rape case; prejudice in case involving unconscious victim; failure to appeal denial of severance; discretion of court; duty of counsel to raise all non-frivolous claims on appeal.
