



Linhardt Civil: Petition for special and preliminary injunction relating to participation in Little League World Series; disqualification due to positive COVID-19 test of coach; limitations on judicial interference into decision of private athletic association; prima facie showing of a fraudulent action, an invasion of property or pecuniary rights, or capricious or arbitrary discrimination; application of six essential prerequisites for preliminary injunction; rational basis for compliance with CDC and Pennsylvania Department of Health guidance, even if harsh result occurs; arbitrary and capricious implementation of mitigation plan; ability of the court to restore the teams to their status as it existed immediately prior to the alleged wrongful conduct; clear right to relief. 
