Criminal: Suppression motion; search of residence incident to arrest; evidence in plain view when police accompanied arrestee to his bedroom to secure a shirt; sufficiency of information in affidavit of probable cause to support search warrant. (Gadson062921bt.pdf) (Posted: July 6, 2021)
- ▶ **Commonwealth vs. Carr** (07/01/2021)—Judge Ryan M. Tira
Criminal: Post-sentence motion; suppression issue decided by another judge; coordinate jurisdiction rule; intervening change in controlling law; warrantless search of an automobile; consent to search as exception to requirements of probable cause and exigent circumstances for warrantless search. (Carr070121t) (Posted: July 6, 2021)
- ▶ **CL Adoption** (07/30/2021)—Judge Joy Reynolds McCoy
Adoption: Petition for involuntary termination of parental rights; proper service; parent demonstrates settled purpose to relinquish parental claim to child or fails to perform parental duties for at least six months; no existing bond. (AdoptionofCL063021m) (Posted: July 1, 2021)
- ▶ **Commonwealth vs. Barasky** (06/25/2021)—Judge Nancy L. Butts
Criminal: Suppression motion; probable cause for arrest; corroboration to substantiate confidential informant's reliability; probable cause to support vehicle stop based on confidential informant's tip; search of cell phone by way of calling it to cause it to power up; fruit of the poisonous tree; habeas corpus motion; prima facie evidence of criminal use of a communication facility; sufficiency of evidence to prove defendant took a substantial step. (Barasky062521bt) (Posted: June 30, 2021)
- ▶ **Commonwealth vs. Martin** (06/25/2021)—Judge Nancy L. Butts
Criminal: Suppression motion; incorrect time stamp on digital video and photographs; weight of evidence; motion in limine; authenticity of video determined based on testimony; habeas corpus petition; prima facie case. (Martin062521bt) (Posted: June 30, 2021)
