

Effective July 1, in accordance with new Commonwealth Orphans' Court Rule 15.6, no petition to terminate parental rights may be filed unless an adoption petition has been filed.

Under new Rule 15.3, separate adoption and termination petitions must be filed for **each** child. Fees will be as follows: Adoption Petition \$65.25 and corresponding Termination Petition \$20.00 totaling \$85.25. Do not combine payment. Separate checks (each made out to The Orphans' Court) must accompany each petition being filed. It is important to note that this is not a fee increase. The "Additional Child" fee of \$12.50 for Adoption Petition on the current fee schedule will no longer be collected.
