Criminal: Habeas corpus petition; sufficiency of evidence of indecent assault related to father tickling his child, patting her butt while clothed or washing her hair; lack of evidence of intent of sexual arousal or gratification related to acts. (Koons021326G) (Posted: March 31, 2026)

- ▶ **Commonwealth vs. Laird** (03/24/2026)—Judge Ryan M. Tira
Criminal: Habeas corpus petition; sufficiency of evidence of stalking with intent to place in fear of bodily injury; evidence of a course of conduct including following in vehicle; appearance in victim's bedroom with loaded gun as placing the victim in fear of bodily injury. - ▶ **Commonwealth vs. Cormier** (03/23/2026)—Judge Ryan M. Tira
Criminal: Motion to dismiss due to pre-arrest delay where statute of limitations has not run; proof of actual prejudice due to loss of evidence; loss of evidence unrelated to delay; lack of prosecutorial bad faith; change of venue due to prejudicial pre-trial publicity that is sensational, inflammatory and slanted toward conviction; sufficient cooling off period between pretrial publicity and potential trial date, such that individual voir dire may address possible prejudicial publicity issues.
