- ▶ **Commonwealth vs. Gallick (02/23/2026)**—Judge Ryan M. Tira
Criminal: Habeas corpus petition; prima facie case; sufficiency of evidence of rape and related offenses of an unconscious victim where victim testified to falling asleep after drinking and using marijuana, and defendant admits that they had sex; testimony of victim that defendant used his hands on her neck, and otherwise assaulted her as well as observed bruising, supporting strangulation, simple assault, harassment and disorderly conduct charges. - ▶ **Commonwealth vs. Thompson (02/09/2026)**—Judge Ryan M. Tira
Criminal: Motion to dismiss; sufficiency of evidence of criminal trespass where victim observes defendant on security camera entering her front door, and he had no permission to enter. (Thompson020926t2) (Posted: February 23, 2026)
- ▶ **Commonwealth vs. Thompson (02/10/2026)**—Judge Ryan M. Tira
Criminal: Motion to dismiss; prima facie case of criminal trespass; person who has a key to a property can be found to have committed the crime of criminal trespass if he enters without permission, and against a forceful effort to prevent his entering. (Thompson020926t3) (Posted: February 23, 2026)
- ▶ **Commonwealth vs. Thompson (02/09/2026)**—Judge Ryan M. Tira
Criminal: Suppression motion; probable cause to issue search warrant; where there were active arrest warrants against defendant for threats of violence, he was found to be wearing a gun holster and he was not permitted to have a gun, there was probable cause to search a vehicle for a gun. - ▶ **US Bank Trust National Association National Bank vs. Scott (02/23/2026)**—Judge William P. Carlucci
Civil: Motion to stay sheriff's recording and delivery of deed after sheriff's sale upon foreclosure; claim that sale price was grossly inadequate; sale properly advertised and subject to competitive bidding; lack of evidence of fair market value of property. (U.S.Bank022326C) (Posted: February 23, 2026)
