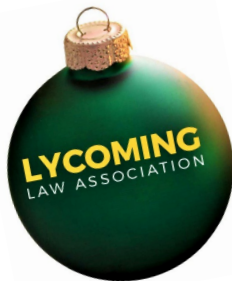
## LLA Angel Tree Drive Collects Hundreds of Toys
