GUARDIAN AD LITEM (GAL)— CHILD WELFARE AGENCY

Lycoming County Children and Youth Services (LCYS) is seeking a qualified attorney to serve as a Guardian Ad Litem (GAL) for children involved in dependency proceedings in Lycoming County.

Duties include: representation of the legal interests of children in dependency matters; review of case records and relevant documentation; consultation with children, parents, caregivers, caseworkers, service providers, and other individuals involved in the child's case, as appropriate; participation in court hearings, permanency reviews, and other proceedings; preparation of reports and recommendations to the Court; and other duties consistent with the responsibilities of a Guardian Ad Litem under Pennsylvania law. The GAL will advocate for the child's legal interests and provide independent representation throughout the dependency proceeding.

This position will be on an **as-needed basis**, and the Guardian Ad Litem will serve as an **independent contractor**. Compensation will be provided at a rate of \$90.00 per hour.

Candidates must be licensed to practice law in the Commonwealth of Pennsylvania and, preferably, have experience in child welfare, dependency, juvenile law, or related legal practice. Candidates should have strong communication, advocacy, and organizational skills, as well as an understanding of Pennsylvania's child welfare and dependency system.
