## **Judicial Appointment**

Governor Wolf has nominated Ryan Tira, who won both nominations during the May primary, to fill the vacancy created by the retirement of Judge Gray. The Senate has confirmed the nomination. Judge Tira will be sworn in on September 4, 2019 at 4:30 p.m. in Courtroom #1. This appointment will continue until the end of 2019. Judge Tira will begin a 10 year term in January 2020.

#### Courtroom #3

Judge Tira will be assigned all matters scheduled for Courtroom #3 for the remainder of 2019. These matters will include civil, criminal, family court, custody and juvenile matters.

Since the Court will have a full compliment of active judges, it is anticipated that Senior Judges will not be assigned except in matters where all active judges have recused themselves.

## **Jury Questionnaires**

The additional questions requested by the Civil Bar and approved by the Court for use on jury questionnaires, have been implemented.

## **Confidentiality Requirements**

The APOC has requested comments from practitioners concerning problems encountered by the confidentiality requirements for pleadings.
