Civil: Preliminary objections; contract claim against non-party to agreement; interpretation of contract term allowing dismissal of employee who was involved in criminal activity in sole discretion of employer; good faith basis for determination; acquittal as raising factual issue of involvement in criminal activity. - ▶ **Skillman vs. Patel, Farr, Does and ABC Business Entities** (12/19/2022)—Judge Eric R. Linhardt
Civil: Preliminary objections; availability of punitive damages in contract and Unfair Trade Practices and Consumer Protection Law claims; reckless, indifferent, willful, wanton, oppressive, or outrageous conduct; pleading notice of bed bug infestation; recoverability of attorney’s fees; American rule; statutory authorization for award of fees. - ▶ **Commonwealth vs. Alford** (12/15/2022)—Judge Nancy L. Butts
