► Commonwealth vs. Hunsberger (12/1/2025)—Ryan M. Tira

Criminal: Habeas corpus petition testing the sufficiency of evidence of child abuse based on a hearsay medical report submitted at the preliminary hearing to establish elements of the offenses, where supported by non-hearsay police officer testimony; prima facie case for multiple counts of endangering the welfare of children, where police are claiming a course of conduct; need for Frye hearing to determine admissibility of expert conclusions, where no novel areas of medicine or methodology are offered. (Hunsberger120125t) (Posted: December 2nd 2025)

► Commonwealth vs. Leonard (12/2/2025)—Nancy L. Butts

Criminal: Post conviction relief act petition; reinstatement of appeal rights where counsel's conduct results in the loss of only some issues; merit of sufficiency of evidence claim, where there was specific and credible evidence of the commission of the crimes of rape of a mentally disabled person, applicable standard views the evidence in the light most favorable to the Commonwealth as the verdict winner; lack of prejudice. (Leonard I 20225bt) (Posted: December 2nd 2025)

▶Commonwealth vs. Reitz (11/26/2025)—William P. Carlucci

Criminal: Habeas corpus petition; sufficiency of evidence of first and second murder charges where defendant provided crack cocaine that is alleged to have caused death, but there was no evidence that killing was intentional or of another felony; use of hearsay testimony to establish prima facie case of murder in the third degree. (Reitz I 12625C2) (Posted: November 29th 2025)

▶Commonwealth vs. Reitz (11/26/2025)—William P. Carlucci

Criminal: Suppression motion; police interview without giving Miranda rights where interview was noncustodial in a place of defendant's choosing with his pastor present. (Reitz112625C1) (Posted: November 29th 2025)

▶ Commonwealth vs. Bausinger (11/24/2025)—Nancy L. Butts

Criminal: Motion to withdraw guilty plea where defendant admits guilt on theft charge, but disputes the amount stolen; fair and just reason to withdraw plea; lack of evidence to change the grade of the offense to which defendant admits; bare assertion by defendant that she stole less. (Bausinger I 12425bt) (Posted: November 25th 2025)

► Commonwealth vs. A.M. (11/21/2025)—Nancy L. Butts

Criminal: Motion to enforce expungement order to order the removal of a court opinion from the database of the official reporter for the Lycoming Law Association; applicability of Criminal History Record Information Act; exemption from expungement for standard methods of making judicial rulings publicly accessible. (A.M.112125bt) (Posted: November 25th 2025)

► Commonwealth vs. Ross (11/20/2025)—Nancy L. Butts

Criminal: Post conviction relief act petition; ineffectiveness of counsel for failing to inform defendant of mandatory minimum sentences, where a significantly lower term of imprisonment was offered for a guilty plea; reasonable basis for failure; lack of prejudice where defendant cannot prove that he would have accepted a lower plea offer, that he previously rejected on advice of his family and where he had never shown any inclination to plead guilty. (Ross I 12025bt) (Posted: November 25th 2025)
