- ▶ **Commonwealth vs. Kolasa** (12/22/2025)—Judge Nancy L. Butts
Criminal: Habeas corpus petition; sufficiency of evidence that the arrest was lawful to support resisting arrest charge; suppression motion; authority of parole officers, who were lawfully present, to access common areas of an apartment, and thereby observe drug paraphernalia and marijuana in plain view; reasonable suspicion to detain defendant for suspicious and threatening movements. (Kolasa12225bt) (Posted: December 29, 2025)
- ▶ **Commonwealth vs. Ruley** (12/26/2025)—Judge Nancy L. Butts
Criminal: Habeas corpus petition; sufficiency of evidence of child endangerment where defendant was merely holding his 2-year-old child during an encounter with police and when he left the child unattended; permitting lesser included charges to be charged separately; evidence of course of conduct where there were several incidents of violence toward a child, during same episode; chargeable course of conduct including both physical and emotional injury; viewing evidence in light most favorable to the prosecution when determining a habeas corpus motion; sufficiency of evidence of reckless endangerment where younger child was endangered by defendant's continuing to attack older child while younger child attempted to intervene; dismissal of mischarged harassment count; factual issues for jury; evidence of public, violent activity and loud threats sufficient to support disorderly conduct charges. (Ruley122625bt) (Posted: December 29, 2025)
- ▶ **Commonwealth vs. Best** (12/29/2025)—Judge Nancy L. Butts
Criminal: Motion to sever cases involving offenses occurring on different dates; admissibility of multiple offenses as proof of a common plan or scheme, identity and absence of mistake or accident; prejudice; habeas corpus petition; sufficiency of evidence to support unlawful contact with minor where there was no evidence that defendant engaged in any enumerated offenses; sufficiency of evidence of furnishing alcohol to minor where there was proof of consumption of alcoholic beverages and there is no requirement of proof of percent of alcohol in the beverage; sufficiency of evidence of child pornography where videos showed naked minors; suppression motion; waiver of issues related to breadth of search warrant for lack of specificity (Best122925bt) (Posted: December 29th 2025)

- ▶ **Commonwealth vs. Gibson** (12/29/2025)—Judge Nancy L. Butts
Criminal: Suppression motion; Miranda issue; investigative detention not constituting arrest or custodial detention; reasonable suspicion based on reports of gun possession; admissibility of volunteered or spontaneous utterances. (Gibson122925bt) (Posted: December 29, 2025)
- ▶ **Commonwealth vs. Ivey** (12/26/2025)—Judge Nancy L. Butts
Criminal: Post-conviction relief act petition; waiver of claims and defenses by guilty plea; waiver of claim that attorney refused to follow his instructions by written acknowledgment that defendant was satisfied with the representation. (Ivey122625bt) (Posted: December 29, 2025)
- ▶ **Commonwealth vs. McGarvey** (12/23/2025)—Judge Ryan M. Tira
Criminal: Habeas corpus petition; prima facie case for home improvement fraud where construction contract was not completed; intent to defraud; inability of court to consider weight or credibility of the testimony or evidence presented. (McGarvey122325t) (Posted: December 23, 2025)
- ▶ **CDH Adoption** (12/23/2025)—Judge Ryan M. Tira
Adoption: Petition for involuntary termination of parental rights; parent demonstrates settled purpose to relinquish parental claim to child or fails to perform parental duties for at least six months; lack of contact in the context of PFA order and repeated misunderstandings and miscommunications on exercise of custody; failure to perform parental responsibilities explained by ongoing custody dispute; best interests of the child. (AdoptionCDH122325t) (Posted: December 23, 2025)
- ▶ **Commonwealth vs. Cunningham** (12/23/2025)—Judge Ryan M. Tira
Criminal: Prima facie case of possession with intent to deliver drugs based on hearsay information from an informant, purchaser of drugs; probable cause for search warrant based on informant's information where reliability of informant is challenged; severance of firearms charges. (Cunningham122325t) (Posted: December 23, 2025)
- ▶ **Commonwealth vs. Rector** (12/23/2025)—Judge Ryan M. Tira
Criminal: Post conviction relief act petition; timeliness; knowing, intelligent, and voluntary plea of no contest; review of record of guilty plea colloquy. (Rector122325t) (Posted: December 23, 2025)
